2019 Property Tax Notices – were mailed on May 10. If you do not receive your notice, contact Renee at 645-3301, ext. 215 to ensure that the County has your correct mailing address on file. **The County Office will be open during the lunch hour until July 2**nd **to accommodate ratepayers during property tax season.**

Payment Options – When paying property taxes online, use County of St. Paul - Taxes and enter the roll number as your account number. Enter each roll number separately. To pay property taxes with a credit card, click on the Option Pay button on the County Home Page. Please note there is a fee to use this service, which is calculated on the screen when you enter the payment amount. This fee is paid to Option Pay.

Road Construction – Road Construction has started on GBC and Double Chip Seal of TWP 590 (Correction Line) for a total project cost of \$2,194,839. Construction started at Highway 36 and is progressing East to Highway 881and is expected to take 5-6 weeks depending on weather. The Construction is being completed by Carmacks and includes ripping up the cold mix, repairing unsuitable sub grade, installing new sub grade/gravel base, and ultimately completing a double chip seal on the surface. Residents are asked to use alternative routes where possible and obey all signage when travelling through construction areas.

Fundraising Opportunity for Non-Profit Organizations – The County is looking for a group to assist with clean up after the LRA rodeo performances. The group will work with a group selected by the Town of St. Paul to clean up after the performances and will receive a \$1250 honorarium as well as the right to work the rodeo supper (hand out plates at the door) in 2020 and will receive the full proceeds (approx. \$2700-\$3,300). Rec Board Member at Large – The County is looking for a resident to sit as a memberat-large on the Town of St. Paul Recreation Board. Members will serve on the board with Elected Officials as well as members at large from the Town of St. Paul. The Board discusses recreation and serves as an advisory board to the Town of St. Paul Council. This committee meets monthly. Members at large will be paid a per diem as well as mileage to attend meetings. **Bylaws –** Council gave first reading to Bylaw 2019-11 to rezone 140.85 acres in Lot 1, Block 2, Plan 1120579 in NE 30-58-9-W4 from Agricultural to Industrial/Commercial. Council also gave first reading to Bylaw 2019-12 to amend the Municipal Development Plan and Bylaw 2019-13 to amend the Land Use Bylaw to allow the creation of a 32 acre parcel within the Agriculture District. Council approved Bylaw 2019-14 to amend the Municipal Servicing Standards to exempt Lot 1, Block 2, Plan 1120579 from requiring an Area Structure Plan.

Council Expenses – Council approved a format for the Statement of Council Fees Summary which will be published on the County website. The spreadsheet will include information on Council salary, subsistence, conference/seminar registration fees, mileage and benefits and will contain a combined total. A separate spreadsheet will also list the meetings, conventions and seminars attended by each Councillor.
