Highlights March 12, 2019 Council Meeting

Waste Transfer and Recycling Station Joint Capital and Operating Agreement – Council renewed the Waste Transfer and Recycling Station Joint Capital and Operating Agreement for the facility located at PSE 16-58-9-W4. The agreement is for a further five-year term. The County covers 25% of the cost of this Transfer Station.

Letter of Support to reduce speed limit on Secondary highway 646 – Council agreed to provide the Town of Elk Point with a letter supporting their initiative to Alberta Transportation to reduce the speed limit from 100 km/hr to 70 km/hr from the intersection of Highway 41 and Secondary Highway 646 to south of the recreation grounds past the curve. The request is due to the traffic accessing the camp grounds, soccer fields, ball diamonds, golf course, transfer station and gravel pits.

Operating and Lease Agreements – Council approved operating and lease agreements with Evergreen Regional Waste Management Services Commission for the transfer stations within the County of St. Paul. Council also approved agreements with Evergreen for the Transfer stations jointly operated with the Town of St. Paul and Town of Elk Point.

Block Parties – FCSS will be hosting block parties in subdivisions throughout the municipality this summer. The local fire departments will be available at some locations to share information from the Wildfire Hazard and Risk Assessment which was prepared by CPP Environmental, and to provide information on assessing your property for fire risks. Information from other County departments may also be available at these block parties. The first Block party will be held May 18th at the Floatingstone Municipal Campground. Other dates and locations will be advertised on the County FCSS website and Facebook page.

Online Camping Reservations – The County is moving to an online reservation system for the Stoney Lake, Lac Bellevue, Westcove and Floatingstone Municipal Campgrounds for the 2019 camping season. Reservations will be accepted starting May 1. Additional information will be available on the County website.
