2015 Audited Financial Statements – are available at the County Office or can be viewed on the County website at www.county.stpaul.ab.ca. They will be presented by the auditors at the **AGM on May 3 at 7:00 p.m. in the Ashmont Fire Hall.**

Fire Permits – Just a reminder that Fire Permits are required for all types of open burning within the County.

Summer Hours for Landfills – Effective April 1, 2016 the Manned Landfill Sites reverted to summer hours. The **Elk Point, St. Edouard, St. Lina, Vincent Lake, and Whitney Lake** sites will be open from 10:00 a.m. to 6:00 p.m. on Tuesdays and Saturdays. **Ashmont** will be open on Tuesday, Saturday, and Sunday from 9:00 a.m. to 6:00 p.m. **Mallaig** will be open from 10:00 a.m. to 6:00 p.m. on Tuesdays and 9:00 a.m. to 5:00 p.m. on Saturdays.

Planning and Development – Council approved Bylaw No. 2016-07 to amend the Land Use Bylaw to allow towers constructed in accordance with CSA S37 to be setback from abutting parcels and roadways a distance of 20 percent of the tower height or the distance between the tower base and guy wire anchors, whichever is greater.

After hearing from adjacent landowners in opposition to Bylaw No. 2016-05 to rezone 10 acres in N ½ NW 13-57-6-W4 from Agricultural to Country Residential, Council defeated the bylaw at second reading.

Spring Cleanup – As a pilot project and in support of residents with spring cleanup in their communities, Council approved the following:

- May 16-24 - Mallaig and Ashmont Transfer stations will remain open from 9:00 a.m. to 6:00 p.m.
- May 16 to 20 – County crews will haul away items left on the curb providing in Ashmont and Mallaig. Information on how debris must be bundled will be provided to residents.
- May 19-24 – Extra bins will be placed at the bin sites in the Crestview and Floatingstone developments.
