Highlights August 13, 2019 Council Meeting

County of St. Paul Library Board Member – The County is looking for a resident to sit as a member-at-large on the County of St. Paul Library Board. The Board Member will serve on the board along with Elected Officials. The board provides financial management and policy direction for County Libraries and operates libraries housed in Ashmont and Mallaig Schools. Meetings are held monthly except during the months of July and August. The board member will be elected for a one-year term. Members at large will be paid a per diem as well as mileage to attend meetings. If you are interested in serving on the County Library Board, submit a letter to pcorbiere@county.stpaul.ab.ca outlining why you are interested and any experience you have pertaining to libraries.

Regional Recreation Master Plan – Council approved the Regional Recreation Master Plan with the Town of St. Paul, Town of Elk Point and Summer Village of Horseshoe Bay. The Regional Recreation Master Plan is a guiding strategic document that will be used to help decision-making and future collaborations between the partner municipalities in the provision of recreation opportunities. The Regional Recreation Master Plan is on the County's website under "Recreation & Campgrounds".

Bylaws – Recent changes to the *Municipal Government Act* means that all Municipalities with common borders must complete and adopt Intermunicipal Development Plans (IDP) by April 1, 2020. The municipalities worked with ISL Engineering and Land Services Ltd. to complete the plans. Council approved the Intermunicipal Development Plans with the Town of St. Paul, Town of Elk Point and Summer Village of Horseshoe Bay. The IDP identifies a 50-year development strategy within the County of St. Paul No. 19 and the Town of St. Paul intermunicipal area. It also provides a set of policies for those lands that will use as a basis for decision-making on land use, transportation and servicing matters within the IDP area. The IDP also informs citizens and businesses on intermunicipal priorities. The plans can be viewed on the County website under "Governance".

FCSS – County of St. Paul and Elk Point FCSS received a Civil Forfeiture Grant. The grant provides funding for the FCSS Department to hire an Outreach Worker to work with youth in the Town of Elk Point and surrounding areas. FCSS will be hosting a Block Party and Summer Drive-in Movie at Ferguson Flats on August 22 showing the

movie 'Cars 3'. Free hotdogs and games from 5 to 7:00 p.m. with the movie starting at dusk. The movie 'Mama Mia 2: Here We Go Again!' will be showing in Mallaig on August 23. The movie starts at dusk and there will be free popcorn.
