August 11, 2020 Council Meeting Highlights

Due to COVID-19, the Council meeting was streamed live on YouTube. Council meetings and Public Works Meetings held during the pandemic are streamed on 'YouTube/ County of St. Paul No. 19 Council Meeting'

Bylaws

Council passed *Bylaw 2020-17 Loan Bylaw* that will allow the County to enter into a loan agreement with the Mallaig and District Agricultural Society. The loan agreement will assist the Society with the purchase of a Zamboni. The term of the loan agreement would be ten years for \$50,000 beginning January 1, 2021.

Council defeated *Bylaw 2020-18* that that would have allowed for private on-site sewage disposal on Lot 1, Block 3, Plan 0227119. The proposed bylaw was defeated because of opposition to that proposal that was submitted to the County.

Council gave first reading to *Bylaw 2020-19* to rescind Bylaw 2016-03 licensing the undeveloped road allowance between NE 22-57-10-W4 and NW 23-57-10-W4. The landowner requested this change.

General Municipal Servicing Standards Amendment Request Council passed a motion for administration to create a bylaw to amend the General Municipal Servicing Standards Bylaw 2014-04 to exclude Lot 2, Block 1, Plan 2021568 (within NE 34-58-10-W4) from requiring an area structure plan. Council passed a motion for administration to prepare a bylaw to amend the Municipal Development Plan Bylaw 2013-51 to reduce the requirement for the Environmental Reserve from 30 metres to 6 metres on Lot 2, Block 1, Plan 2021568 (within NE 34-58-10-W4) and that all associated costs will be paid by the landowner.

Request to Maintain Municipal Reserve at Crestview Beach Council passed a motion to approve the request from the adjacent landowner to cut the grass on Lot 233MR, Block 5, Plan 7922205.

Floatingstone Estates Access Road between Lots 39 and 40 To ensure the safety of local residents, Council passed a motion to erect signs indicating 'Caution: Children Playing' and 'No

ATVs' on the access road off of Bidlock Drive that has been used by the general public to access the beach and lake.

Donations and Grants

Council moved to provide two loads of cold mix for the Elk Point Golf & County Club at an estimated value of \$1,419. The cold mix will be used to enhance cart paths, the parking lot, and some high traffic areas.

Council moved to donate 50 tonne of gravel to Haying in the 30's to assist with site maintenance caused by flooding.

Council moved to provide the STARS Foundation with a \$2 per capita donation for 2020 at \$12,936. The County has contributed \$2 per capita to STARS since 2016.
