The Public Works Building remains closed to the public.

2020 Surplus Transfer to Reserves Council approved the transfer of \$1,325,000 from unrestricted surplus to reserves for future expenditures in the 2021 fiscal year.

2020 Audited Financial Statements Council approved the 2020 Audited Financial Statements following the presentation of these statements by Shawn Warrington of Synergy CPAs. These statements will be available on the County's webpage once they are duly signed by the Reeve and Interim CAO.

Council moved to accept the proposal to **transfer the following to the County from the Town of Elk Point** as of May 1, 2021: Elk Point Fire Department's invoicing for Fire Calls and that the 2017 Fire Services Agreement be amended; grass cutting at the East Cemetery for the 2021 season and to invoice the Town of Elk Point for the cost; and, to establish a Joint Transfer Station Committee.

Council approved the work project proposal from Urban Systems at a cost of \$67,500 related to development of a phasing plan to replace the **aging water and sewer infrastructure** in the Hamlets of Ashmont, Lottie Lake and Mallaig.

County approved reducing two **fire invoices** pertaining to structure fires in the County. Council has also asked Administration to provide further information regarding invoicing for fire calls at the Public Works meeting on April 27, 2021.

Tender for Standing Hay on NW-59-11-W4 Council approved tendering 11 acres of standing hay for another two-year term for 2021 and 2022.

Council moved to make a \$1,000 donation to the St. Paul MS Walk to be held on May 20, 2021.

Council moved to make a \$7,000 donation to the **2nd Chance Trail Ride Society** 10th Anniversary fundraising event that will be held on May 8, 2021 in Elk Point. The event is a drive-in fundraiser in support of the organization that brings awareness to organ and tissue donation. \$5,000 will be allocated from an operating reserve set aside for supporting the Elk Point area and \$2,000 will come out of the community donations fund. The parking pass and other perks included with this level of sponsorship will be donated back to the Society.

Additional Information

Roadside Spraying Program A No-Spray Agreement *must be signed with the County before April 30 each year* to ensure no spraying is done near private property. Call the Agricultural Services Board staff at 780-645-3306 to make an appointment as the Public Works Shop is closed to the public.

Spring Cleanup – month of May County residents can dispose of fridges, freezers and water coolers that contain Freon without paying the \$20 Freon removal fee during Spring Cleanup. *The fee waiver is valid only during Spring Cleanup in May.* Items can be taken to County and Town Transfer Stations and to the Evergreen Regional Landfill.
