### January 11, 2022 Council Highlights

Council meetings and Council Public Works Meetings are live streamed on 'YouTube/County of St. Paul No. 19 Council Meeting'.

Council enacted **Bylaw 2021-22** to license the road allowance between SW 14-58-7-W4 and NW 11-58-7-W4.

Council rescinded **ADM-26 Land Leases Policy**. The policy will be revised and brought back for Council's consideration.

Council approved Collette Labrie as a board member-at-large, representing the St. Paul and District Ag Society, to the **Town of St. Paul Recreation Board**.

Tenders for **County-owned Lands for Lease** were opened. Tenders will be awarded at the January 24 Public Works Meeting.

Council rescheduled the **January Public Works** meeting to Monday, January 24 at 10:00 a.m.

Council approved setting the date of the **Public Auction of Lands** to May 10, 2022 at 11:00 a.m.

Council approved the submission of applications to the provincial government for both the **Provincial Education Recreation Credit and Designated Industrial Requisition**. This program allows the County to receive a credit for School and Designated Industrial Property requisitions where the taxes remain uncollected, but the requisitions have been paid to the Province. In the past in order to apply under this program the County was required to write off the uncollectible taxes; however, the Province has changed the program allowing the municipality to apply without writing off municipal taxes.

Council moved to waive the \$1,000 **rezoning application fee** for Lot 1, Plan 9923585 in SE-2-61-10-W4 as it was the County that arbitrarily zoned the property in the 2013 re-write of the Land Use Bylaw.

Council moved to provide a letter of support in principle to the **Village of Vilna** to accompany their Alberta Community Partnership grant application for 2022-23 to complete a Management Plan for the North Saskatchewan River under the Canadian Heritage Rivers System.

Council approved annual funding to the **Riverland Recreational Trail Society** in the amount of \$6,720 per year for a three-year term commencing 2022 through to 2024.

Council approved providing a letter of support to David Hanson MLA to rename Highway 28 as the **'Victor Ringuette' Memorial Highway**.
