June 14, 2022 Council Highlights

Council meetings and Council Public Works Meetings are live streamed on 'YouTube/County of St. Paul No. 19 Council Meeting'.

From the May 24 Public Works Meeting

Council approved entering into a Service Contract with A&T Water & Septic Ltd. for wastewater removal services for the Municipal Parks for the 2022 and 2023 seasons, as per the Services Contract.

From the June 14 Council Meeting

Council amended Bylaw 2022-09 related to the Land Use Bylaw 2021-13 Re: Alternative Energy. A Public Hearing was held during the June 14, 2022 Council Meeting. The bylaw will be brought back to the July 12, 2022 Council Meeting.

Council amended Bylaw 2022-10 related to the Municipal Development Plan 2021-14 (MDP) Re: Alternative Energy. A Public Hearing was held during the June 14, 2022 Council Meeting. The bylaw will be brought back to the July 12, 2022 Council Meeting.

Council passed Bylaw 2022-12 Cemeteries Bylaw and rescinded Cemeteries Bylaw 2017-28.

Council approved the Elk Point Regional Allied Art Society be included in the County's Electricity and Natural Gas contract with 8760 group.

Council moved to inform Windsor Salt Ltd. that the County will not purchase the water treatment plant when they cease operations in August 2022.

Council approved construction of a rail fence, sign and riprap to prevent public access to a drainage area and to reduce erosion at the Environmental Reserve located at Lot 39ER, Block 1, Plan 8721423 at Vermilion Beach on Laurier Lake.

Council approved the request to name Range Road 100 north of Township Road 592 to the Westcove Municipal Park Entrance to Girard Road.

Council approved the submission of a letter to the County's Member of Parliament and Senate members in support of Bill C-234, Resolution 5-22: Exemption of Natural Gas and Propane for Agriculture Producers Under the Greenhouse Gas Pollution Pricing Act.

Council approved sending a letter of concern to the Alberta Utilities Commission regarding the rising cost of utility fees within the province.

Council approved a \$1,000 transportation grant for the St. Paul Centennial Senior Citizen's Opportunity Club.

Council approved providing the Elk Point Pioneer Circle Seniors Recreation Centre with a waste bin and charge only when tipping is required.

Council approved the request to deliver up to 25T of gravel at no cost to Whitney Lake Bible Camp located at SW-16-56-4-W4.

Council approved a contribution in the amount of \$4,236.80, the Municipal Portion of property taxes, to the Mann Lake Golf Course to offset their operating costs.

Council approved the request from the Reconciliation St. Paul Committee for \$200 to assist with the cost of fuel and accommodation for the theatre group taking part in the production taking place on August 4, 2022.

Council approved the Bronze Level sponsorship at \$500 for the Fetal Alcohol Spectrum Disorder (FASD) Virtual Conference being held October 5 and 6, 2022.

Council approved a letter of support for the Capella Centre in its application to CMHC Transitional Housing to build an 18-unit Transitional Housing Building.

Council approved providing St. Paul Army Cadets with a grant of \$2,000 for 2022.
